Many ADR practitioners have thought – and some still think – that business disputes can be best resolved only in face-to-face meetings. But two developments have shaken this assumption: Businesses urgently need to resolve many claims of relatively small amounts, that do not individually justify the investment of such processes; and technology has invited interactivity that replicates – and sometimes improves upon – face-to-face communication. This panel will review how Online Dispute Resolution (ODR) first began, and how it has come into its own as a viable and, in some situations, preferable method of resolving certain types of commercial conflicts. The challenges: How to ensure private justice in high volumes of claims of low amounts? How to reduce transaction costs to provide for efficient outcomes of claims? And how to convince business people of the merits of these processes?
